I. Decision and information disclosure of the repurchase and cancellation of the Restricted A Shares

On 12 January 2024, the Company convened the first extraordinary meeting in 2024 of the eighth term of the Board and the first extraordinary meeting in 2024 of the eighth term of the Supervisory Committee, at which

the proposal in relation to the repurchase and cancellation of the Restricted A Shares granted to certain Participants under the Restricted A Share Incentive Scheme for 2020 and the adjustment of repurchase price was considered and approved. Due to resignation or the assessments results failing to satisfy the Unlocking Conditions or other reasons, 9 Participants under the Incentive Scheme of the Company no longer satisfy the stipulations relating to the Participants in the conditions of grant. Pursuant to the relevant stipulations of the Restricted A Share Incentive Scheme for 2020 (Revised Draft) of Zijin Mining Group Co., Ltd.* (the "Incentive Scheme"), the Company decided to repurchase a total of 582,300 Restricted A Shares granted but not yet unlocked held by the abovementioned 9 Participants under the Incentive Scheme.

The Company has fulfilled the procedures in relation to noticing creditors for the repurchase and cancellation of A Shares pursuant to the stipulations of the laws. The notice period has reached 45 days. The Company has not received any request from the creditors in relation to debt repayment or provision for the corresponding guarantees, nor has the Company received any objections from creditors on the matters of the repurchase and cancellation.

II. Repurchase and cancellation of the Restricted A Shares

(I) Reasons and basis for the repurchase and cancellation of the Restricted A Shares

Due to resignation or the assessments results failing to satisfy the Unlocking Conditions or other reasons, 9 Participants under the Incentive Scheme of the Company no longer satisfy the stipulations relating to the Participants in the conditions of grant. Pursuant to the relevant stipulations of the Incentive Scheme, the Restricted A Shares held by the abovementioned 9 Participants that have been granted but not yet unlocked will be repurchased and cancelled by the Company.

(II) Relevant personnel and number of Shares to be repurchased and cancelled

A total of 9 Participants are involved in the repurchase and cancellation of the Restricted A Shares. An aggregate of 582,300 Restricted A Shares will be repurchased and cancelled. Upon the completion of the repurchase and cancellation, the number of remaining Restrictive A Shares under the Incentive Scheme will be 32,755,904.

(III) Arrangement of the repurchase and cancellation

The Company has set up a specific securities account for repurchase at the China Securities Depository and Clearing Company Limited Shanghai Branch (the "CSDC Shanghai Branch") (account number: B884520988). The Company has also applied for the repurchase and cancellation procedures at the CSDC Shanghai Branch. It is expected that the cancellation of the Restricted A Shares will be completed on 19 March 2024. The Company will follow up on the procedures for the changes in industrial and commercial registration and other related procedures in accordance with the laws.

III. Change in share capital structure of the Company before and after the repurchase and cancellation of certain Restricted A Shares

Upon the completion of the repurchase and cancellation, the total number of Shares of the Company will be changed from 26,326,571,240 to 26,325,988,940. The change in the share capital structure is set out below:
